Uncle Bub's Backyard Cook-Off 2017 May 27, 2017

Welcome to the Uncle Bub's Backyard Cook-Off 2017. This is a KCBS Sanctioned Backyard Contest this year. In this contest, Amateurs will be cooking Chicken AND Ribs. Cook timing is key to winning this contest. For this contest, your chicken and ribs will be judged on **Appearance, Taste and Tenderness**. Each of these 3 categories will be judged from 1-9 with 9 being the best. **KCBS Rules will apply**, please familiarize yourself with them. We will make every attempt to utilize KCBS Certified Judges for this contest but cannot guarantee it.

The following guidelines will apply:

Summarized KCBS Rules (make sure to read the complete rules on our website):

- **TEAMS:** Teams must be comprised of backyard BBQ'ers. **NO PRO TEAMS** are allowed. Backyard teams may not solicit the assistance in cooking from a pro team during the contest. All teams must be able to carry their own equipment to the site. **NO EQUIPMENT OVER 300 POUNDS (OVERSIZED) ALLOWED!!** Vehicles are not allowed on the field.
- **CHECK-IN:** Check in time will begin at 7:00 AM (not before). The earlier you check in, the more time you will have for preparation and cooking.
- **CHICKEN:** Your chicken **MUST** be inspected prior to seasoning and cooking to ensure they are in their packaged raw natural state (no pre-marinating is allowed).
- **RIBS:** Your ribs **MUST** be inspected prior to seasoning and cooking to ensure they are in their packaged raw natural state (no pre-marinating is allowed).
 - Ribs must be Spare, Loin, Baby-Back or St Louis cut. **No Country style allowed.**
- **GARNISH:** Garnish is optional.
- **SAUCE:** Meat may be sauced or not, as cook sees fit.
- **CONTAINERS:** The only containers allowed are those provided by contest representatives. Containers must not be marked or the exterior altered in any way. Number tag assigned and affixed by representative should not be altered in any way. The assigned number **SHALL BE THE TOP** of the container.
- **PORTIONS:** There shall be a minimum of 6 portions presented in the container. Ribs may be turned in with double bones, single bones, heavy meat on both sides of a single bone and if desired a touch of loin meat attached to the rib bone. Be sure each portion is cut through so that Judge does not have to pull portions apart. Remember: There are 6 judges per table.
- **TURN IN:** Chicken: 3:00 PM and Ribs: 3:30 PM (5 minutes before and after each time listed)
- **GRAND CHAMPION & RESERVE GRAND CHAMPION:** The Grand Champion and Reserve Grand Champion will be determined by a combination of your scores in accordance with KCBS Rules

Winners to be announced around 5:30 PM from the stage.
KCBS Rules will apply to this contest. Make sure you read them

LEGAL STUFF

Only alcohol purchased from the Westmont Lions Club will be allowed on property owned by the Westmont Park District and the Village of Westmont. Electric is NOT provided. **Violation of this note is good cause for immediate disqualification at the discretion of the event organizers. No refunds will be made.**

Teams will use every precaution available to protect the Westmont Park District grounds from excessive litter and burning of grass. Garbage receptacles will be provided on the grounds. ALL hot coals shall be disposed of in the appropriate "HOT COAL" barrels. Your competition area shall be clean at the end of the contest.
